

1. **Online Safety – All – Action**

Keeping children safe online and ensuring children can increasingly keep themselves safe by identifying risks, to themselves and others, and take appropriate action to keep themselves safe is a priority for families and school communities. Parents may find the following site helpful - <https://www.net-aware.org.uk/>. The information on the site provides families with information about online facilities in an accessible format e.g. Their reviews identify the intensity of the risk – You tube and Minecraft (pocket edition) are shown below. They also provide common sense guidance and advice to supplement the images below.



The NSPCC are working in partnership with Net Aware and a particularly helpful section of their website focuses on children being 'Share Aware' and uses the acronym TEAM. We will also be using the TEAM acronym during the year as part of our curriculum efforts to help children keep themselves safe on line.

Mobile Applications – Safeguarding Concerns

It has come to the attention of the safeguarding team the 'Amino' App significantly increases safeguarding risks for children whom use it. We would advise parents to reassure themselves that their child is not using this App. If they are then it would be advisable to chat through content your child may have experienced when using the App. It is entirely possible that parent may not be able to effectively stop their child using this App (children are ingenious at accessing things adults would not allow!); therefore it is essential that children have effective supervision and guidance from parents regarding their online behaviour and how they can keep themselves safe.

Common Sense Media Review:

Parents need to know that Amino - Communities, Chat, Forums, and Groups is an app that lets users join online communities related to anime, gaming, books, and more. This app lets users explore all available Amino communities and create their own groups; there are also other community-specific apps from the same developer, such as Poké Amino. While the communities are predominantly positive, bad language, violent references, and sexual themes crop up throughout, making this a potentially iffy choice for young teens.

2. Understanding & dealing with issues – All – Action

The Department for Education have issued guidance on understanding and dealing with issues relating to parental responsibility.

All schools are required by law to engage with pupils' parents in a number of different ways. They can find themselves caught up in disputes between a number of adults, each claiming to have parental responsibility for a particular child or by making requests on school staff that, by statute or good practice we would not be able to fulfil. Schools are also expected to navigate complex living arrangements, particularly for children who are living in social care, where parental responsibility can be confusing or unclear. Whilst we always seek to achieve a reasoned and reasonable outcome based parental requests this can, at times, be frustrated by parents who are experiencing an acrimonious separation with a previous partner or spouse. We are sharing the DFE 'parental responsibility' guidance as a reference tool for all. We hope it will enable parents, experiencing difficulties, uncertainties or frustrations with 'parental responsibility' to find the answers they need and an understanding the schools position when requests are made by parents may be difficult for a school to accept due to the legal and 'good' practice guides that schools operate within.

Who is a parent?

Parents may be recognised differently under education law, than under family law. Section 576 of the Education Act 1996 states that a 'parent', in relation to a child or young person, includes any person who is not a parent (from which can be inferred 'biological parent') but who has parental responsibility, or who has care of the child.

For the purposes of education law, the department considers a 'parent' to include:

- all biological parents, whether they are married or not
- any person who, although not a biological parent, has parental responsibility for a child or young person - this could be an adoptive parent, a step-parent, guardian or other relative
- any person who, although not a biological parent and does not have parental responsibility, has care of a child or young person
- A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.

What is parental responsibility?

In [family law](#), parental responsibility means all the rights, duties, powers, responsibilities and authority that a parent has in relation to the child.

A person with parental responsibility can make decisions about the child's upbringing and is entitled to information about their child. For example, they can give consent to the child's medical treatment and make decisions about the child's education. They also have the right to receive information about their child's health and education.

Who has parental responsibility?

A child's birth mother (the person who carried the child) has parental responsibility unless it's removed by an adoption order or a parental order following surrogacy.

Where a child's father and mother were married to each other at the time of the child's birth, they each have parental responsibility for the child. Where the parents were not married to each other at that time, the child's father can gain parental responsibility:

- by registering the child's birth jointly with the mother
- by subsequently marrying the child's mother
- through a 'parental responsibility agreement' between him and the child's mother which is registered with the court
- by obtaining a court order for parental responsibility

Where two female parents have a child through fertility treatment, the mother's female partner is treated in the same way as a father. She has parental responsibility if she is married to or in a civil partnership with the mother at the time of the treatment (or if the two women agree in writing that she will be the child's second parent). She can also acquire parental responsibility in the same way that a child's father can.

People who are not the child's biological mother, father or second female parent can also [acquire parental responsibility](#).

Civil partners have parallel rights to married people in terms of parental responsibility. The same provisions for married people apply to them in terms of:

- acquiring parental responsibility - adoption, agreement with their civil partner or by an order from the court
- holding parental responsibility
