So what is fact and opinion?

Fact = a thing that is known or proven to be true

Opinion = a view or judgement about something not necessarily based on fact or knowledge.

WALT differentiate between fact and opinion.

It's important to be able to spot both fact an opinion in texts that we read, as this will also help us to include both in our own writing.

The language of fact and opinion

How do we distinguish between fact and opinion?

One way to distinguish between fact and opinion is to look at the language used. Language helps us to decide whether a statement can be backed up with evidence and verified in some way. Or it can help to show whether the statement is someone's point of view, judgement or belief.

Examples of the language we use to express facts:

- This review has demonstrated...
- According to the results of the latest poll...
- The latest findings confirm...
- · Researchers have recently discovered...

Tip: look at the key words used to express facts - demonstrated, according, confirm, discovered.

Examples of the language we use to express opinions:

- The company claims that...
- · The research team argues that...
- In Professor Donald's view...
- Most experts in this field suspect that...

Tip: Look at the key words used to express opinion - claims, argues, view, suspect.

NOTE: Facts and opinions can be manipulated. Opinions can be presented as facts, simply by using the language of facts to present them. For example:

Recent statements made by the council confirm that most residents do not want a further expansion of the one-way system of streets.

Although facts are expressed in the language in the above statement, there is very little evidence to back it up. The council may have made statements about increasing the number of one-way streets, but this doesn't mean that local residents were surveyed and that their responses were recorded in any way.

We usually use different language to indicate that a statement is either fact or opinion.

In Mau 2016, a three-year-old boy climbed into a gorilla enclosure at Cincinnati Zoo in the USA. To protect the child, staff at the zoo shot dead the gorilla who lived in the enclosure — a large male called Harambe. This article argues that it is wrong to keep animals like gorillas in zoos.

The only thing more upsetting than Harambe the gorilla's death was the reality of his life

Surely we can begin to agree that animals which * share 98 per cent of our DNA should not be kept as entertainment for us to gawk at in a zoo.

Yet again, captivity has taken an animal's life. 'The 5 latest victim: a 17-year-old gorilla named Harambe, who was gunned down after a young boy managed to crawl through a fence before falling into his enclosure at the Cincinnati Zoo.

The incident (which could have been prevented 10 by surrounding the enclosure with a secondary barrier) has generated a great deal of debate online. [...] What we should be asking is why intelligent, self-aware animals are still being displayed as living exhibits for humans to gawk at.

- 15 Harambe and other animals serving life sentences in zoos are leading lives of quiet desperation. They are denied the most basic freedoms, including being able to choose where to roam, when and what to cat, and whom to socialise with. It's no
- 20 wonder that these magnificent animals frequently exhibit signs of extreme depression and related psychological conditions. [...]

Zoos try to justify their existence in the name of "conservation", but warehousing animals in these

25 facilities does nothing to help protect endangered animals in the wild. In fact, some say doing so

- actually harms wild populations because it diverts much-needed funds away from the protection of animals in their natural habitats.
- 30 After all, capturing (yes, some zoos still snatch animals out of their natural habitats), transporting and maintaining non-human animals for the professed purpose of "conserving" them is enormously expensive. It costs about 50 times
- 35 as much to keep one African elephant in a zoo as it would to safeguard sufficient natural habitat to sustain that elephant and countless others.

When, in 2007, the Zoological Society of London spent £5.3m on a new gorilla enclosure, Ian

- 40 Redmond, the chief consultant to the UN Great Apes Survival Partnership, said: "15m for three gorillas [seems a huge amount] when national parks are seeing [three gorillas] killed every day for want of some Land Rovers, trained men and anti-
- 45 poaching patrols. It must be very frustrating for the warden of a national park to see". Clearly, the same amount of money a zoo spends on buying expensive animals could benefit so many more of the same animals living in the wild. Our need
- 50 for entertainment is expensive, unnecessary and without discernible* benefit, then, to the animals involved.
